To apply for the Skilled Regional Sponsored – 489 Visa the applicant must meet the basic requirements as set down by the Department of Immigration and Border Protection (DIBP) and include the following supporting documentation:

- Completed NSW Form R,
- Completed Form 956 (if using a Migration Agent),
- Current Resume/CV,
- Certified copy of IELTS test results,
- Certified copy of appropriate skills assessment,
- Certified copies of all educational qualifications and academic transcripts,
- Certified copy of passport details page (for applicant and dependants),
- Evidence of processing fee payment
